

MASTER OF ARTS IN TEACHING PANHANDLE ALTERNATIVE CERTIFICATION FOR EDUCATORS

The MASTER OF ARTS IN TEACHING/PANHANDLE ALTERNATIVE CERTIFICATION FOR EDUCATORS (MAT/PACE) program is a university-based teacher certification program for bachelor-degreed individuals who want to make a career transition into the teaching profession. The first half of the program, PACE, is designed to lead into Texas educator certification which begins with testing, early field-based experiences, and online graduate course work. An eligible candidate may be employed as a Texas teacher or may complete clinical teaching under the supervision of an experienced teacher. The second portion of the program may culminate into an advanced degree with continuation of online graduate course work and a graduate comprehensive exam.

APPLICATION REQUIREMENTS

The following minimum requirements apply to <u>all</u> applicants:

- □ A bachelor's degree from a regionally-accredited institution of higher learning, -AND-
- □ An overall grade point average (GPA) of at least 2.75 on a 4.0 scale on all college *and/or* university course work attempted <u>or</u> a 2.75 GPA on the final 60 hours, -AND-
- □ A passing score report on Texas Examination of Educator Standards (TExES) for the target certificate -OR-
 - a minimum of 2 score reports of 230 or higher (on <u>each</u> section of Core exam) <u>and</u> course work specific to the content/grade level of the target certificate (see p. 3) with a 2.75 GPA

Applicants with degrees from universities other than WTAMU must submit sealed, certified transcripts from every college and/or university attended. Applicants with degrees from universities outside the U.S. should contact the program prior to application. These applicants must also submit a TOEFL score report with a score of 26 on the speaking portion.

Applicants currently enrolled in a bachelor's program may be granted contingent admission during the final semester of undergraduate enrollment provided all of the above criteria are met.

APPLICATION/ADMISSION PROCESS

Step I—PACT testing: Prior to program application, determine the content/grade level of the target certificate and take the applicable Texas Examination of Educator Standards (TEXES) through the *Pre-Admission Content Testing* (PACT) system. If a minimum of 2 score reports is 230 or higher on content exam(s) [230 for <u>each</u> section of the Core exam] <u>AND</u> content course work meets the minimum requirements outlined on page 3, a passing score of 240 is not required for admission.

Step 2—Application: Submit a copy of the TExES score report(s) with the application, fee, and other required documents listed on page 9. After your application has been evaluated, you will be notified of program approval status by email within 30 days.

Step 3—Program admission: If you are approved for the program, you will be given an offer of admission and certification plan, and you must confirm acceptance of the offer within ten days of receiving the plan. Upon confirmation, you will receive additional information regarding the graduate school application, field-based experiences, and registration. If you are not approved, you may contact the PACE office to discuss your options.

TESTING/TRAINING/TEACHING

Every initial teacher certification candidate in Texas must complete a preparation program which includes the "Three T's" – Testing, Training, and Teaching.

Testing

Texas educators must pass at least two exams for full certification—a content exam and the Pedagogy and Professional Responsibilities (PPR) exam. Certain programs may require more than two tests. Applicants must submit official TExES content exam score reports with the program application. Passing the exam is an important factor in employment eligibility as a teacher, and may be used in determining eligibility for admission. The PPR exam will be taken after program admission upon completion of appropriate course work.

It is important to prepare for the exam because each candidate is limited to one initial attempt and four retakes. A list of <u>Test Preparation Resources</u> is available in the testing folder under *LINKS*.

Training

Training includes early field-based experiences and professional development (PD) course work in accordance with the approved certification plan.

Early Field-based Experiences Requirements (prior to clinical teaching or internship)

Candidates are required to complete a minimum of 40 clock hours of field-based experiences prior to a supervised teaching experience with WTAMU's EPP. This requirement may be met through face-to-face field experiences or a combination of face-to-face (at least 25 hrs) and video (up to 15 hrs). **Substitute teaching may not be used for field experience**; however, other public school experience may be considered on a case-by-case basis by the Director of WT's EPP. The *Field-Based Experiences Packet* includes specific procedures for placement procedures by the EPP Director and is available from the *LINKS* folder on the PACE website, <u>www.wtamu.edu/PACE</u>.

Professional Development Course Work

Professional development (PD) course work required of all candidates is offered online and is completed during the summer, fall, and spring semesters following admission (see page 4). Required course work will be listed on a candidate's certification plan; however, it is the candidate's responsibility to contact PACE staff each semester for advising and registration.

Teaching

Each candidate must complete a supervised teaching experience through one of two options:

- 1. **Internship**: an eligible candidate is hired as a paid teacher of record in a TEA-accredited public school or a TEA-recognized private school. The candidate will complete WT forms to be granted a 1-year intern certificate and will teach fulltime for two semesters at the grade level and content area of the target certificate. A candidate may request eligibility and begin applying for teaching positions after passing the content exam, completing early field-based experiences, and completing 12 SCH, including EDPD 6332 and EDPD 6331. Candidates must notify WT when hired to arrange supervision and to complete internship paperwork.
- 2. **Clinical Teaching**: an eligible candidate completes a 14 week unpaid experience (formerly known as student teaching) in the classroom and under the supervision of a certified teacher. A candidate must have completed early field-based experiences, passed all required exams, and completed all PD course work prior to clinical teaching. Candidates must submit the clinical teaching application to request formal placement to be arranged by WT with approved ISD partnerships. CT applications are on the PACE website under LINKS.

REQUIRED CONTENT COURSE WORK

An applicant who has not passed the content exam for the target certificate <u>may</u> be approved to begin professional development course work if the 2 score report(s) display a minimum score of 230 or higher <u>and</u> the transcript verifies required semester credit hours (SCH) of content course work with at least a 2.75 GPA.

Please note:

- Starting Sept 1, 2017, all ACP candidates must have appropriate the TExES content exam passed, 40 hrs of early field experience, and 12 SCH of PD course work, including EDPD 6332 and EDPD 6331, for internship.
 A special education candidate is not eligible to teach without passing the special education exam <u>and</u>
- another content exam (EC-6 or 4-8 Core Subjects or the applicable 7-12 exam if a resource teacher).

Passing the content exam is of utmost importance; however, state policy limits a candidate to five test attempts: one initial and four retakes. Please access and use the <u>Test Preparation Resources</u> under *LINKS* on the PACE website prior to taking the exam.

PROFESSIONAL DEVELOPMENT COURSE WORK

Professional development course work required of all candidates is offered online and is completed during the summer, fall, and spring semesters following approval. Course rotation by semester (FA-fall, SP-spring, or SU-summer) is provided for planning purposes, <u>but is subject to change</u>.

MASTER OF ARTS IN TEACHING

Individuals in the PACE program are concurrently in the Master of Arts in Teaching (MAT) program. The MAT program will allow PACE candidates to complete requirements for initial teacher certification, expand their knowledge and skills to support their effectiveness as teachers, and meet state certificate renewal requirements in their respective fields.

NOTE: The MAT degree will <u>not</u> lead to a professional certificate (counselor, diagnostician, or principal); however, certain MAT courses may serve as leveling courses for other graduate programs. If a professional certification is the goal, contact PACE for referral to the appropriate adviser for that program.

Admission Requirements

- Apply to WT's PACE program (separate from and prior to graduate school application); see <u>wtamu.edu/PACE</u>.
- Upon program approval, apply to graduate school using the Grad U.S. Application, <u>wtamu.edu/admissions/apply_graduate.aspx</u>, for the "Education/Teaching Masters program" and submit the fee.

MAT Course Work (36-42 hrs)

A minimum total of 36 semester credit hours (SCH) of <u>graded course work</u>—at least 24 hours at the 6000-level—is required. Course work includes the following:

- 18 SCH of Professional Development course work through PACE
 - (candidates may not continue past PD until content exam is passed)
- 9 SCH from the graduate core in Education
 - EDPD 6303, and
 - 3 SCH from EDPD 6304 or EDPD 6385 or COUN 6330, and
 - 3 SCH from EDLD 6311 or EDPD 6305 or EDPD 6308 or EDPD 6329
- 9 SCH in the applicant's teaching field as approved by the graduate adviser in the Department of Education
- Possible Additional 6 SCH candidates completing clinical teaching will be enrolled into 6 SCH (EDPD 6398/6399) of pass/fail or 0 SCH for candidates who complete internship

Degree Completion/Graduation Requirements

A candidate must meet these requirements to graduate with the MAT degree:

- Hold a Standard Texas Educator Certificate (complete all testing, training, and teaching requirements), and
- Completion of all course work as outlined on the official MAT Plan of Study, and
- Passing a written comprehensive exam. Note: The candidate is not eligible to sit for the comprehensive exam until standard certification is complete.

Other Considerations

- The candidate may request a MAT Plan of Study from the PACE Adviser upon completion of 12 SCH of Graduate PACE course work *and passing the content test(s) for the target certificat*e.
- The candidate must maintain a 3.0 GPA (with no grade below a C) on all MAT course work, and the program must be completed within six (6) years of taking the first graduate course that applies to the MAT degree.

PACE PROGRAM COST

These are approximate costs associated with program application:

- \$131.00 for the TEXES content exam
- \$50.00 non-refundable PACE program application fee

These are approximate costs associated with program participation:

- \$40.00 non-refundable graduate school application fee
- \$131.00/certification exam (at least 2 are required of every candidate, content and PPR)*
- Approximately \$1100.00 /course for in-state tuition and fees*
- Textbooks and supplies (varied by course estimate not provided)

These are approximate costs associated with the supervised teaching experience:

- Option 1 Paid Internship [eligible candidate being hired on by ISD]
 - \$78.00 fee for an intern certificate*
 - \$37.75 for the criminal background check fee*
 - \$10.00 fee for the digital fingerprinting service*
 - \$2700.00 internship supervision fee (paid through school district payroll deduction, \$300.00/month for nine months)
- Option 2 Clinical Teaching [previously known as student teaching]
 - o Approximately \$2100.00 in tuition for the 6 SCH Clinical Teaching courses, and
 - \$1200.00 clinical teaching supervision fee [program fee separate from tuition]

Upon completion of all certification requirements, these are additional costs:

- \$78.00 fee for the Texas Standard Teaching Certificate*
- Tuition/fees for additional course work to complete the MAT degree (optional)

*Exam fees, certificate fees, and fingerprinting fees are set by the Texas Education Agency and are subject to change. Tuition and fees are established by the Texas legislature and are subject to change; estimates for Texas and border county residents are provided; residency status is determined by the Admission's Office.
