WT Enters into Agreement with Cengage and McGraw Hill

Pursuant to <u>President Wendler's pledge to WT provide free textbooks</u> for students enrolled in core courses beginning in the Fall 2024 semester, WT has contracted with major publishers Cengage and McGraw-Hill. Although the initiative was primarily targeting students in core courses, the range of topics covered by these two publishers has the potential to benefit students in non-core courses at both undergraduate and graduate levels for students in classes whose instructors select materials from either of the two publishers. Additionally, students in core and non-core classes may benefit from instructors who identified other low-and no-cost solutions such as OER from their work last fall, following President Wendler's announcement. Generative AI in Higher Education

Opinions are mixed among instructors and professors in higher education about the place AI may or may not have in the learning arena. Here is a short read revealing some insights from early adopters.

Regardless of your stance...

Every faculty member must select <u>one</u> of the three required statements to be included in your syllabi for the Fall semester:

No Use of Generative AI Permitted

Because writing and critical thinking skills are part of the learning outcomes of this course, it is a violation of academic integrity to employ generative AI at any point in this course.

Integrating generative Al into higher education: Insights from early adopters

Use of Generative AI Permitted Under Some Circumstances with Permission

There are specific situations within this course where you will use generative AI to explore how the technology can serve as a complimentary learning tool. The course faculty member will inform when, where, and how you may employ these tools, along with guidance for attribution. Any use outside the faculty defined parameters constitutes a violation of academic integrity.

Generative AI Permitted with Attribution

The use of generative AI is permitted in this course to help prepare assignments and projects. When submitting work, students must clearly identify any generative AI content in contrast to student contributions (e.g., student citation of prompts, the generative AI platform used, the date the prompts were issued, and related). Using an AI tool without proper attribution qualifies as a violation of academic integrity.

INSTRUCTIONAL TECHNOLOGY

New Process for Adding Panapto Videos to WTClass

Panopto, the university tool for sharing premium video content in courses, has updated the process for adding video to WTClass. This new process is designed to be more user-friendly and will make integrating video into your courses easier. LMS Transition from Blackboard to Canvas

After a five-week faculty evaluation, which included a faculty feedback and recommendation survey, West Texas A&M University will transition to a new Learning Management System (LMS), Instructure's Canvas, on June 4, 2025. This launch date coincides with the 2025 Summer I semester.

As the current LMS contract expires on July 31, 2025, WT's instructional technology team is fully committed to working toward a seamless transition to Canvas. In preparation for the transition from Blackboard to Canvas, faculty members were carefully screened and selected to serve as mentors to colleagues within each of the academic colleges. The role of mentors is to learn the Canvas system as an early adopter, prepare and teach a course in Canvas in the Spring 2025 pilot semester, and provide expertise, assistance, and encouragement to colleagues in navigating the migration to Canvas. Faculty mentors for our college will be announced later in August.

Additionally, to keep everyone informed and up to date on the progress of the migration, the instructional technology team has created a <u>dedicated migration website</u>. This website will serve as a central hub for information, resources, and training updates related to the transition to Canvas. You are encouraged to check the site regularly as we transition to the Canvas environment. The migration website link is <u>Canvas Migration Website</u>. Faculty training opportunities are anticipated to roll out in the fall.

Thank you for your patience and understanding throughout this process and your continued dedication to the success of our students. Your support and cooperation are essential as we work together to make this transition as smooth and successful as possible.

Call for Applications: Dyke Rogers Professorship

This professorship is established within the Hill Institute and the Terry B. College of Education and Social Sciences. Appointments for endowed professorships in the Terry B. Rogers College of Education and Social Sciences are reviewed every three years for continuance or reassignment based on satisfactory performance of the faculty with the intent of the endowment as evidenced in an annual report of the recipient's professional activity submitted to the College Dean, Hill Institute administration, and Dyke Rogers or his designee. The appointment typically commences on September 1 of the academic year following the appointment; however, the dean may approve an alternative start date in consultation with the donor.

Professorships provide the recipient during the term of the appointment with discretionary funds based on a determined annual spendable percentage of the value of the endowment. Allowable expenditures may include, but are not limited to, program enhancement, research, curriculum development, graduate assistants, computer software and hardware, professional development and/or journal subscriptions and/or related expenditures approved by the dean. The funds may not be used to supplement the appointed faculty member's salary. The use of funds will be reported annually on or before August 31 to the Dean of the Terry B. Rogers College of Education and Social Sciences and Dyke Rogers.

Eligibility criteria:

- The professorship may be awarded to an assistant, associate, or full professor (associate or full professor preferred) in Education and Social Sciences and demonstrate evidence of, or expressed desire to continue instruction, scholarship and service that impacts the quality of life for communities of the Texas Panhandle;
- Record of scholarly activity and teaching effectiveness in the discipline specified by the professorship;
- Record of impactful professional service that advances initiatives in the college; and
- To align with the donor's intent in establishing the professorship, the faculty member should understand and respect the values and beliefs of the donor and be willing to work within the Hill Institute.

In the third-year review of the endowed professorship service, the College Dean may continue the appointment or announce a call for applications for a subsequent appointment. Before the endowed professorship term expiration and the formal call for applications, the College Dean will consult with the donor and designee, when appropriate, to determine whether to renew the faculty appointment in the professorship or consider other applicants as the best path forward to advance the college mission. When reassignment of the professorship is determined, applications must include a current vita and a statement about how the appointment will enhance the candidate's scholarly activity, teaching, and professional service. While an endowed professorship is typically a three-year minimum appointment with the possibility of renewal for consecutive three-year terms, the College Dean can terminate a professorship appointment at any time, subject to consultation, when appropriate, with the donor or designee.

The Terry B. Rogers College of Education and Social Sciences Recognition Committee will review applicants and forward a recommendation of two to three finalists to the College Dean for consideration. Selection will include a faculty interview with the College Dean, Hill Institute administration, and Dyke Rogers or his designee before finalizing an appointment to ensure faculty and donor general values and philosophies align. The Dean will forward a recommendation to the University Provost/Executive Vice President for Academic Affairs. The Provost/Executive Vice President for Academic Affairs will appoint all endowed professorships subject to the university president's approval.

The Rogers have generously committed to funding seven professorships as follows: Educational Leadership, Education (Science of Teaching Reading), Psychology, Social Work, Sociology, Criminal Justice, and Political Science. Four are now funded, one of which is held by Dr. Janet Hindman. I am seeking applications to award three more in the fall – one in education and two in the social sciences. The application requires the submission of a current CV and a statement about how the appointment will enhance the applicant's scholarly activity, teaching, and professional service. The deadline for applications is September 1st. Applications should be emailed to the Dean at gbigham@wtamu.edu.
