West Texas Panhandle Chapter ENA Trauma Nursing Core Courses (TNCC) 2025

The TNCC Provider course is designed to provide core level trauma knowledge and psychomotor skills associated with the delivery of professional emergency nursing care to the trauma patient. The content we present is a combination of online pre-course modules, presentations, and psychomotor skills stations.

To maximize success in this course, we recommend that the participant have at least six months of clinical emergency nursing experience. We assume that the course participant possesses generic nursing knowledge, understands emergency care terminology, and is familiar with standard emergency medical equipment.

Registrations and payment arrangements must be received at least 40 days prior to the Course so the student has their manual at least 30 days prior to the course.

LVNs, Paramedics, and Physicians may audit the course for CE credits. Only Registered Nurse attendees will be awarded a verification certificate of completion by the ENA upon successful course completion.
