- You may attach the following optional item to your application: Copy of CPR card - If you have taken the American Heart Association Healthcare Provider CPR course, attach a copy of your CPR card. Otherwise, you will be able to take one of the CPR classes offered by the Laura and Joe Street School of Nursing at New Nursing Student Orientation or during the first two weeks of classes.
